dear ilias,

i need from you a breakdown of the security threats in greece. here are some definitions and data so you know what should be on the breakdown: "security" is defined as 'a condition of being safe' and a threat is defined as 'sign a cause of possible evil or harm'. any instances of possible (ul) harm to the safety of church organizations and operations are counted on the security threats stat. you count 1 point per sec threats. this is an invest stat. here are examples of what you would count:

- moonlighting staff (whereby a company would pull out staff from

pts type b or c situations of a staff or public.

5 staff or public involved in a custody case because he/she is a scapist.

- connections to arm or aquirre groups.

- involvement in other practices.

- other than org businesses on org lines or org premises.

- any staff or public attracting heavy antagonism from someone outside the church which might result or has resulted in an attack.

- a (suspected) plant, spy.

- theft of documents or materials.

- squirrelizing of tech or admin.

- persons spreading rumors enturbulating staff and public.

- sabotage, especially of dissident lines.

physical security aspects of the org: locked doors, confidential data secured, somebody pushing illegal deals like loan deal.

- enturbulating persons coming on erg lines (db's, type 3, drunkards, psychotics, etc).

- a scientologist turning type 3.

- a scientologist involved in gross financial irreg's/illegalities

one thing which should be counted (unless you have new data) is the 100 calls which were received by the mission 2 weeks ago from persons wanting to be dead filed.
