Dear capt. Bill,

In July I ran into some interference on my SOL I, where I had a dial wide R/S without perceiving the source of it. You advised me at that time to look for the creator of my body org. That I did, I contacted a being who seemed to be this creator, I audited him very successfully to full EP.

A few days later I felt that I might be pregnant, which was welcome to me and Martin.

I started getting in comm with the lambdas of that new developing body, but couldn't really get a C/O or creator or anything that I could identify. All I got was the perception of a kind of a rough sketch of a body. When I contacted it, it blew apart into many particles which vanished, and when I gave them the MOC! they as-is-ed easily.

After that, whenever I tried to contact the embryo I got something amorphous, impossible to differentiate, which gave me the idea, it could be twins.

Then, around the 1st sept I started bleeding, but just a few drops and only every other day, and upon contacting that area of the body I got the impression of a kind of cleaning out unnecessary stuff from the womb.

On the 12th of sept. around 4am the bleeding became a bit stronger, and I got the clear feeling, that the pregnancy was at its end. Around 2pm the blood started rushing out quite fast.

At 5pm Martin drove me by car to the hospital.

In the car the "interesting" part started. My body went into what the doctors call a "shock". The body started withdrawing the blood -at that time it had lost ca. 10% of its blood- from the arms and feet, cold sweating started all over the body, vision went down, I started seeing fiery, glowing circles around everything, then the body closed the eyes.

When I asked the body org for data, it gave me the explanation that it needed all the blood left to operate heart, lungs, brain and other important inner organs and I better shouldn't force any movements on it. I agreed and let the body hang in the seat of the car AND THUS COULD STAY COMPLETELY CONSCIOUS. I informed the body org that I would cooperate and that it was on the way to hospital anyway for help. At that point the body stopped bleeding, took up the normal functions again, and when we arrived at the hospital I was able to walk inside, sit down and wait for the doctor to arrive.

The doctor sent me to the operating room right away for a curettage. There I got a general anaesthesia. I don't recall very much from this period, I know I was exterior to the body, but I don't have any visio or audio recall from that. About 30 mins. after the anaesthesia had started everything was over and

already on the way from the operating room to my room I came back to awareness. Hearing and vision turned on.

At this point I decided to help the body org recover, and did the following: I got in comm with all the lambdas of the body and told them "feel your neighbour" and "perceive your environment" and gave them an r-factor as to what had happened.

After ca. 5 mins of doing this I was back to full awareness, and my body org started a full repair program.

After a rest period of about 2hrs. I got back into comm with my body org, and we reconstructed the following:

The creator of the body org I had handled in July was in fact the creator of the body org of the embryo. When he was handled completely he had decided that he didn't want his creation being the body org of my baby and withdrew it. My body wanted to jump in (in a kind of by-pass and handle) and "create a new body org for the organism under construction to help me having a baby". This didn't work out, they didn't have enough hatching to do it, and didn't cooperate, because I didn't know what was going on. So they decided get rid of the failed experiment.

Then I handled their ARC-breaks and MWHs on that, and after 24 hours all tests doctors did on me in the hospital were back to normal.

The funny thing was, that one test, the blood count, in fact was already normal the next morning. And since I had lost about one liter of blood, the doctor accused the lab of having made a mistake with the test, as the result was "normal blood count". So he ordered another test, which also was "normal". He attested I had an iron constitution and released me from hospital in the afternoon. (Normal stay would have been 3 days.)

My cognitions out of this:

1. When the body goes into a shock after loss of blood it is because the body wants to force the body into immobility since they need all oxygen left for the vital organs. If one is in good comm with the body one can avoid unconsciousness.
2. A miscarriage can happen, if the creator of the body-org of the embryo or withdraws the body org.
3. A process should be worked out, where the mother-to-be could create in cooperation with her own body-org a new body org for the body of the baby to prevent miscarriages already IN THE STATE OF PLANNING TO HAVE A BABY. (I am willing to pilot this, as I am actually planning to give it another try to have a baby.)
4. I would recommend from this, that for pregnant women processes which affect creator and structure of the body org of the baby should be forbidden, unless they are able to provide ersatz.
